Agenda Item #1: Welcome, Roll-Call, & Vacancy

The Chairman, Mr. Michael Geyer, welcomed all members and guest present. It was also announced that Ms. Allie Wyatt has resigned from her position on the board, representing the Public-At-Large, Universal Collection Area.

Agenda Item #2: Approval of Minutes

MOTION: *Approve minutes for the meeting held on March 12, 2021.*

Motion stated by Leticia Perez; seconded by Max Goossen. Motion was unopposed.

Agenda Item #3: Fees – Land Use PowerPoint presented by Ms. Lynn Brooks

Ms. Brooks gave a presentation on the Costs & Impacts of State Legislation SB 1383. She mentioned the County's current goal is to produce an implementation plan that meets the requirements of the legislation and coordinates with the incorporated Cities and is cost effective and easy to use.

Agenda Item #4: Franchise Hauler Update presented by Mr. Craig Pope

The department has undertaken the task of updating the contracts with the Franchise Haulers. Larry Moxley announced the Zone 2 haulers and Mountainside Disposal are in the process of selling their companies to Burrtec Industries.

Agenda Item #5: Removing & Preventing Illegal Dumping (R.A.P.I.D.) Update presented by Ms. Lisa Shreder

Ms. Lisa Shreder, Public Works Manager, presented updated totals for the R.A.P.I.D. crew: 2,968 sites cleared, 672.44 tons of waste hauled including 779 mattresses (436 recycled, 56%) and 270 encampments. To reduce illegal dumping occurrences, the department has proceeded with plans to host more Bulky Waste Collection Events throughout the County. Seven events have occurred so far, and a second Bakersfield area event is planned for October 23rd, 2021.

Agenda Item #6: Landfills Treated Wood Waste & Landfill Gas Update presented by Mr. Tony Bonanno

In January, generators and transporters were required to apply for variances in order to dispose of treated wood waste at the landfills. Mr. Bonanno mentioned that the Bena landfill is accepting all loads, the Shafter & Taft landfills are not accepting large loads, and Transfer Stations and Eastern Kern landfills have a 2 cubic yard limit.

Agenda Item #7: SB 1383 – Notice of Intent to Comply presented by Ms. Lynn Brooks

The date of compliance for SB 1383 is January 1, 2022. Ms. Brooks announced the department will be sending a letter of notice of the County's intent to comply with the legislation.

Greg Ollivier with City of Bakersfield mentioned his appreciation for the County's work in helping the Cities with SB 1383 and making it easier for everyone.
